



## Private Daycare fees Reimbursement



**Did you know that sending your child to a private daycare like Académie Marie-Emmanuel is not as expensive as you may think?**

Why? Because the Quebec government refunds you back at the end of the month up to 75% of what you pay, depending on your total family income.

### How to calculate the government refund:

**Example:** John and Suzan have a total family income of 33,500\$ per year. They have one child of age 3 years that goes to Académie Marie-Emmanuel daycare. John and Suzan will initially pay 35\$ per day. John and Suzan apply for refund from the Quebec government by filling out the form TPZ-1029.8.FV. They will receive back 26.25\$ per day for their child at the end of the month. So the real cost to send their child to Académie Marie-Emmanuel is 8.75\$ per day.

Also, at the end of the year, John and Suzan can include the amount paid to Académie Marie-Emmanuel in their Federal income tax report which will be deducted from their net revenue thus paying less income tax.

**The following table illustrates the real cost of sending one child to Académie Marie-Emmanuel with respect to the Total Family Income.** (Source : Revenu Québec)
